# **Combined efforts to overcome inflation**

# <u>All Macao residents</u>

- Each eligible Macao citizen will receive a one-off injection of 10,000 patacas as start-up funds for his or her individual central savings account;
- Each eligible Macao citizen will receive a further injection of 6,000 patacas into his or her individual central savings account;
- Each permanent resident will receive 7,000 patacas, with each non-permanent resident receiving 4,200 patacas under the Wealth Partaking Scheme;
- Each permanent resident will receive a 500-pataca health care voucher;
- Each residential household will receive 180 patacas per month towards electricity fees;



- The Continuing Education Programme will continue with a subsidy programme, in which each local resident reaching 15 years old will receive a subsidy of up to 5,000 patacas;
- Waiver of the first 3,500 patacas of real estate tax;
- Waiver of the real estate stamp duty on the first three million patacas of a home's value, for Macao permanent residents purchasing residential properties for the first time.

# **Caring for the elderly**

- Raise the Old-age Allowance to 6,000 patacas for each eligible senior citizen; 👚
- Increase pension to 2,000 patacas per month for each eligible citizen.

Smart tips for senior citizens Old-age Allowance : 6,000 patacas Pension : 2,000 patacas x 13 months Wealth Partaking Scheme : 7,000 patacas Further injection into each central savings account : 6,000 patacas

Total amount received for the year = 45,000 patacas

# Low-income families

- Raise the minimum subsistence index to 3,200 patacas;
- Raise the income ceiling for the Short-term Food Assistance Programme to 1.7 times the minimum subsistence index;
- Disburse extra one-month full subsidy to families who are recipients of financial subsidies registered with the Social Welfare Bureau;
- Provide special subsidies and special living allowances to three categories of disadvantaged families;
- Provide rent waiver for public housing tenants for one year;
- Increase the temporary housing subsidies to eligible families on the waiting list for public housing. Each one- to two-member family will receive a monthly subsidy of 1,250 patacas; each family of three or more members will receive a monthly subsidy of 1,900 patacas;
- Increase the financial allowances to 4,400 patacas for low-income, full-time employees;
- Promote the Positive Life Programme and the Community Employment Assistance Scheme.

#### <u>Students</u>

- Provide a study allowance of 2,000 patacas per academic year to each Macao citizen who is a registered student of a tertiary educational programme;
- Continue provision of textbook allowance of 1,700 patacas per school year to all Macao secondary and primary school students, and 1,500 patacas per school year to pupils in kindergartens.

#### Employed citizens

• Continue providing 25 percent reduction in personal income tax, with the basic allowance set at 144,000 patacas.

#### <u>Business Owners</u>

- Provide waivers of all business taxes, hawker licence fees, wet market stall rents, inspection and quarantine fees for live food, and stamp duties on life insurance, non life insurance and bank service charges;
- Provide waivers of signboard taxes for businesses; exemption from tourism tax for restaurants;
- Maintain increase in profit tax allowance from 32,000 patacas to 200,000 patacas;
- Provide waiver of stamp duties on entrance passes and tickets for cultural and arts performances, exhibitions and entertainment programmes.

#### Homes for all

- Reserve land in the areas available for development in the urban and newly reclaimed areas in Macao, for building public housing estates in future;
- The plan of building a reserve of 6,300 public housing units has commenced;
- Relax the requirements for the income floor and ceiling of applicants of Home-Ownership Scheme Housing, to allow 80 percent of Macao households to meet the conditions for income limits under the scheme;
- Launch the provision of 19,000 public housing units and give priority to families who have long been in the queue for public housing;
- The selection process for the Home-Ownership Scheme housing block in Lot TN27 in Taipa will soon be launched, followed by the scheduled selections of other Home-Ownership Scheme housing projects.

# Sustainable Economic Development

# Adequate diversification of the economy

- Steadily develop the gaming industry, adequately regulate the scale of gaming industry development, strengthen monitoring of the gaming industry and facilitate growth of associated integrated tourism industries;
- Focus on boosting development of Macao's convention and exhibition industry, cultural and creative industries, Chinese medicine industry, and commercial and trade services; continue to support traditional industries;
- Increase the upper loan limit of the SME Assistance Scheme to 600,000 patacas.



### **Regional cooperation**

- Establish the Assessment Committee for the Macao Projects for Hengqin Development that support Macao enterprises with establishing operations in the Guangdong-Macao Industrial Park, and prepare for construction of the Chinese Medicine Industrial Park;
- Follow up the applications to the central government for incentives and initiatives as new growth engines to strengthen competitiveness;
- Establish the Macao Economic and Cultural Office in Taiwan.

# **Raise Integrated Living Standards**

## **Population policy**

- Conduct a consultation on the Framework of Macao Population Policy for analysis and study;
- Step up relevant studies of the middle class, and further solicit middle class opinion.

#### **Enhance medical services**

- Allocate more resources to medical services and implement the Plan for Perfecting the Medical and Healthcare System;
- Strengthen the functions of organisations for training doctors, increase the student intake of the two nursing institutions, and optimise preliminary checks under the triage system to reduce the waiting time for specialist out-patient services.

#### **Improve education policy**

- Increase child-care facilities to provide a wide range of child-care services;
- Safeguard teachers' working conditions in terms of educational system, professional qualifications and funding, to strengthen the increase in teaching staff;

Relax the family income ceiling for

applicants of student loans;



- Establish a comprehensive human resources database;
- Construction of the New Hengqin Campus of the University of Macau will be completed by the end of 2012.

#### Develop strategies for the ageing population

- Conduct further studies of population policy, track the ratio of elderly people in the population and initiate an integrated study of elderly people's medical, housing and retirement protection needs, to gradually build a well-organised retirement protection system;
- Disburse monthly pensions and increase the Old-age Allowance;
- Promote the public consultation on the Framework Law on the Rights of the Elderly;
- Improve medical services for the elderly;
- Advocate the fine tradition of respect for the elderly, to let elderly people enjoy life in retirement within an amicable environment.

#### Inject capital to the social security system

 Study the potential for injecting capital to the Social Security Fund; define the rights and responsibilities of each related party to maintain sustainable operation of the fund.

#### Urban planning and transport

- Formulate the reclamation plan of Macao's new districts and initiate the public consultation for the next phase;
- Persist in the "Public transport first" policy;
- Issue a further 200 taxi licences through an open bidding process.

#### Strengthen environmental protection

- Study formulation of vehicle exhaust emission standards, enhance the strategy for controlling sources of noise pollution, and formulate emission standards for kitchen exhaust;
- Prioritise the use of products meeting higher environmental protection standards, and plan to introduce an electric bus pilot scheme for selected routes;
- Conduct research on the Master Plan for Recycled Water in Macao; and strive to complete construction of recycled water pipelines at the new campus of the University of Macau and in the new residential district in



Seac Pai Van, as well as the recycled water plant in the Coloane Sewage Treatment Plant in early 2014.

#### **Good public order**

Further strengthen the police force's human resources and technology, and enhance police work within the community.

### **Food supplies**

- Move the live food wholesale market into the Macao section of the Zhuhai-Macao Crossborder Industrial Zone, where the number of stalls will increase to 250, thus introducing more competition;
- Facilitate the legislative process for the draft law on food safety, to support the establishment of the Centre for Food Safety and its staff training programmes.



# Home and care services

 Follow up the application to the central government for the import of mainland China domestic helpers, and formulate the law concerning these helpers.

# **Scientific Administration**

Perfect the operation of public administration

- Launch a study on modifying the government structure, which will help rationalise overlapping functions and allocation of public resources;
- Study the establishment of a Civil Service Pay Council, in order to set up a fair, independent and scientific pay adjustment mechanism for civil servants;

• Step up supervision of integrity in both the public and private sectors, steer the creation of a community anti-graft system; and strengthen work to build a foundation of information technology in auditing, to promote an auditing culture.

#### **Crisis management**

• Establish a chief executive-led coordination mechanism for handling various crises. This will be founded on the current four major crisis response systems: regional and international emergency cooperation, public health, civil defence and tourism.

#### **Development of political system**

• Provide a proposal on whether to modify and – if so – how to modify the method for the formation of the fifth Legislative Assembly in 2013, and the selection of the fourth Chief Executive in 2014; conduct public consultations according to actual needs; perfect the election laws and promote an election culture upholding fairness and justice, to drive development of Macao's political system in a steady and orderly manner.
