We invite members of the public to submit their views on the implementation of the ICCPR in respect of those topics, and to suggest any additional topics that should be included in the report.
- 2. We will carefully consider all the comments and suggestions received. Any persons or organizations wishing to offer views are invited to send them to the Legal Affairs Bureau (DSAJ) on or before 12 February 2018.

### Information relating to each of the Articles of the Covenant

### Article 1 together with Article 25: Progress and development of democracy

We will update the Committee on developments in respect of:

- The amendments to MSAR's electoral system, promoting steadily its democratic political development and the freedom of its residents to pursue their own collective economic, social and cultural development.

We will address paragraph 7 of the concluding observations of the Committee in relation to Article 25 related to universal and equal suffrage and the consideration of steps leading to the withdrawal of the reservation to Article 25 (b) of the Covenant.

# Article 2 together with Article 26: Rights to equal protection before the law and to non-discrimination

We will update the Committee on developments in respect of:

- The effective measure to give effect to such right, including available remedies
- The Ombudsman
- Other MSAR monitoring mechanisms on Human Rights matters, such as Commission for the Protection of Victims of Violent Crimes, the Refugees Commission, the Commission for Disciplinary Control of the Security Forces and Services of Macao, the Data Protection Office, the Commission to Follow Up the Implementation of Dissuasive Measures against Trafficking in Persons, the Commission for Senior's Citizens Affairs, the Commission for the Rehabilitation of Persons with Disabilities, Commission for Women and Children Affairs (CWCA)
- Human rights dissemination, education and training
- Enjoyment of labour rights by non-resident workers, monitoring and remedies

We will address paragraph 5 of the concluding observations of the Committee in relation to the apparently limited level of awareness of the provisions of the Covenant among the judiciary, the legal profession and the general public and the independence of the Commission against Corruption (CAC) from the executive power.

We will address paragraph 17 of the concluding observations of the Committee in relation to the practice of employing migrant workers and effective mechanisms to counter abuses on migrant workers.

We will address paragraph 14 of the concluding observations of the Committee in relation the inadequate staffing of the court system; the substantial backlog of cases; the delays in proceedings; and the reported difficulties non-Portuguese speakers may face due to inadequate interpretation during court proceedings.
